Notice is hereby given that the Ingersoll Township Planning Commission, pursuant to Public Act 110 of 2006, will hold a Public Hearing on April 20, 2026 at 7:00 PM during a regular planning commission meeting. The meeting, held at Ingersoll Township Hall, 3026 South Sasse Road, Freeland, MI 48623, will review of the following:

Applicant DTE Electric Co. request for a special use permit and site plan approval for the purpose of constructing a 129 MW (AC) large-scale solar energy system, consisting of solar panels, inverters, retention basins, and setback areas, comprising over 626 fenced acres of land in Sections 10, 15, 21, 22, and 27 of Ingersoll Township. The development has been given the title of the Poseyville Solar Park.
